Kroger Community Rewards Program

Dear Participant,

The Kroger Fundraising program is tracked via your Kroger Plus Card. You will need to link your Kroger Plus Card to Cardinal Stritch online at: www.krogercommunityrewards.com using the organization number: **81624**.

Whenever you make a purchase at Kroger and swipe your REGISTERED Kroger Plus Card, that purchase will *contribute towards the following school year's tuition*. In addition, once a household member registers, then all linked Kroger Plus Cards used by family members will also contribute.

To qualify for earnings you **MUST** register your card with Kroger at www.krogercommunityrewards.com, beginning April 1.

FAQ Section

1. How do I register my Kroger Plus Card and receive my earned Kroger Rewards toward my tuition?

Registration is completed online at Kroger's secure website: Anytime after April 1.

To Enroll:

Go to www.krogercommunityrewards.com - click Create An Account. You will then be instructed to check your email and verify your email address. After email address verification you can then update your personal information. Then click on the Community Rewards section in your profile page and enter the organization number above (this is easier than name) – click the search button (if you hit enter – you will get an error message) – 2) the name and address for your organization should come up (in place of the zip code will be the NPO number). Be sure to click inside the circle to the left of the name – 3) Click the Save Changes button and it should put you back into the profile page – scroll down to Community Rewards and you should see your enrollment.

To Re-Enroll:

Go to www.kroger.com – sign in – choose Account Summary – Account Settings – scroll down to Community Rewards – Click Edit – choose your organization number – click search – name, address, NPO number comes up – be sure to click inside the circle to the left – save changes – again, you should be put back into the profile page – scroll to Community Rewards and see name – number – enrollment date.

Please note: Re-enrollees will earn credit for their April purchases BUT new enrollees will NOT begin earning credit until May 1.

2. Do I need to enroll each year?

Yes!! You DO need to re-enroll at the Kroger website EVERY APRIL – No matter when you register.

3. How do I know my Kroger Plus Card is registered?

Within 7-10 business days of successfully registering your Kroger Plus Card online, you will see at the bottom of your Kroger receipt, "at your request, Kroger is donating to "Cardinal Stritch"

4. Does everything in my shopping card count towards my tuition?

Households can earn rewards on almost everything, every time they shop! However, there are specific purchases that cannot be included: alcohol, tobacco, government-assisted pharmacy expenses, postage stamps, Kroger gift cards and green dot prepaid cards, gift certificates, bottle deposits, lottery and promotional tickets, fuel, fuel center purchases, office services and sales tax. Eligible pharmacy purchases include out of pocket co-pays for non-government-assisted pharmacy programs.

5. How much can I earn toward my tuition?

You will be able to earn Kroger rewards on a quarterly basis. Kroger earnings are based on the percentage of spending of Cardinal Stritch families related to the total spending of all participating Kroger Community Rewards organizations. Kroger does limit its quarterly contributions to all participating eligible organizations and households. These amounts are subject to change yearly. \$1,250,000.00 divided by the number of organizations participating – a percentage of your organization's overall spending compared to companywide sales. 1% of your earnings will be donated to Cardinal Stritch, and the rest will be applied towards the following year's tuition.

6. Once I have enrolled, is my personal information secure?

Kroger does not sell, trade, or rent customers personal information to outside companies or marketing firms. Please read their complete Privacy Policy online at www.Kroger.com.

7. What information will Kroger share with Cardinal Stritch/SKCA?

Kroger no longer shares ANY personal information with the school. Kroger will issue earning checks to the school *and it will be up to the individual Kroger cardholders to provide proof of rewards to the school for the application of credit to tuition accounts*. Your rewards will show on your personal Kroger.com profile page each quarter.

8. How can I view a report of my household's rewards and provide proof of such to Cardinal Stritch?

Proof of rewards will be available through Kroger's website on profile pages established and maintained by Kroger cardholders. It will be up to the cardholders to provide the information to Cardinal Stritch. The Kroger Reward Earning Statement will be found on our website.

9. Can I earn rewards for more than one organization/school at a time?

No, your Kroger Plus Card can be linked to only one organization at a time. However, you may choose to give to two organizations by changing your non-profit organization every six months.

10. How can my family members and friends who are not a part of my household help me with earning toward my tuition?

They must register online at Kroger's website: www.krogercommunityrewards.com. When enrolling or re-enrolling Kroger Plus Cards in the Kroger Community Rewards Program each household that is registering must have their own email address. If you have friends and family members that want to register their card they must have a working email account and provide the email address during the registration process.

Free email accounts are available through many providers, including but not limited to: gmail, aol, yahoo, hotmail, etc. If an account is created for this process just remember to write it down and check it occasionally to prevent it from becoming dormant. Cardinal Stritch does not have the ability to establish these various email accounts. FYI: Public libraries have computers with internet access.

Kroger's quarterly cycles are as follows:

- 1st Qtr – May 1-July 31 (earnings will post by end of August)
- 2nd Qtr – August 1-October 31 (earnings will post by end of November)
- 3rd Qtr – November 1-January 31 (earnings will post by end of February)
- 4th Qtr – February 1-April 30 (earnings will post by end of May. **NOTE** that these earnings will apply to the **2020-21** school year.)

Earnings will be posted on a quarterly basis, BUT, each quarter earnings will be replaced with the most recent quarter earnings, SO YOU MUST PRINT OFF YOUR EARNINGS QUARTERLY AND TURN THEM INTO THE MAIN OFFICE! If you do not print off your earning within the time period, you will lose those earnings! It is to your benefit to print and turn in your earnings with this cover sheet to the main office preferably within one week of posting.
